Over the years, the scheme has become popular and has been beneficial for both the Members as well as the Branch.

For the Members, it is a considerable saving financially and it obviates the inconvenience of individual registration for each programme.

The CPE Credit requirements for the calendar year is 40 hours for Practicing CA's and 20 hours for members not holding Certificate of Practice, so it is necessary for members to plan in advance to meet the above requirements.

Accordingly, the Branch plans to conduct a number of Seminars and Meetings on varied topics such Direct & Indirect Taxation, Company law, Auditing, Accounting standards ,Bank Audit etc.,

In addition to the above, special topics could be arranged based on the suggestions from honorable members. Also Unstructured CPE meetings such as Study Circle Meetings are also planned which is free for ARS Members.

The ARS is Applicable with effect from 01-04-2026 to 31-03-2027. The ARS fee is fixed at Rs.4000/- plus GST, will be open only till 15<sup>th</sup> April, 2026.

**An early bird discount of Rs.500/- is offered up to 05<sup>th</sup> April 2026.**

Thereafter, the normal rates shall apply till 15.04.2026. Members, who have not paid ARS before 15th April 2026, have to make payment for the programmes attended between 01.04.2026 and 15.04.2026 and also must pay the appropriate amount for continuing ARS.
